Art. 18 Duties

- ¹ The AML Control Authority has the following duties:
 - a. it grants recognition to the self-regulatory organisations or withdraws such recognition.
 - it supervises the self-regulatory organisations and the financial intermediaries directly subordinated to it.
 - it approves the regulations issued by the self-regulatory organisations in accordance with Article 25 and any amendments thereto.
 - d. it ensures that the self-regulatory organisations enforce their regulations.
 - e. it specifies in detail the duties of diligence in terms of Chapter 2 for the financial intermediaries directly subordinated to it and stipulates how these duties must be fulfilled.
 - f. it maintains a register of the financial intermediaries directly subordinated to it as well as of persons to whom it has refused authorisation to act as a financial intermediary.
- ² It may carry out on-the-spot inspections. It may instruct auditors of its own choice to carry out inspections.
- ³ In relation to self-regulatory organisations of lawyers and notaries, it must instruct auditors to carry out the inspections. The auditors are governed by the same duties of confidentiality as lawyers and notaries.
